Informed Consent: As the parent/guardian of the registrant, I agree that we will abide by the rules of Doral Soccer Club Inc. (DSC), the state association (FYSA, USCLUB), and all affiliated organizations. I acknowledge that my/our child wishes to participate in soccer during the current season and understand that this participation carries inherent risks. These risks range from minor injuries to severe injuries, including the possibility of death, paralysis, or other serious, permanent disabilities. I accept these risks as a condition of my/our child's participation.

Insurance Notice: All injuries must be reported within 5 days of the date of the injury.

Registration: \$200.00 (City of Doral Non-residents + add 20%)

Regular Season Payment Fee: \$1,350 (September 1st to May 31st). Please note that the competitive uniform kit and any additional leagues or extra training sessions will incur an additional cost.

Payment Plan options:

- 1- Full payment of season due before June 3, 2024 – Payments can be made with check or cash for \$1,350.00 or online via Pay-Pal for \$1,404.00
- 2- Installment payments:
 - First initial payment (regular season) due June 3, 2024 – Payments can be made with check or cash for \$700.00 or online via Pay-Pal for \$728.00
 - Second payment (regular season) due September 2, 2024 – Payments can be made with check or cash for \$325.00 or online via Pay-Pal for \$338.00
 - Third payment and final (regular season) due November 1, 2024 – Payments can be made with check or cash for \$325.00 or online via Pay-Pal for \$338.00

Note: The registration club fee covers the period from September 2024 to May 2025. Teams that begin training in June, July, or August are required to pay \$200.00 per month.

This is a legal and binding contract. Regardless of whether your child participates in a limited number of games or the entire season, you are responsible for the full payment to Doral Soccer Club Inc. (DSC) for the season listed above. By signing this payment plan contract, you agree to take full responsibility for attorney's fees incurred in attempts to collect the total amount due. The payment plan is a privilege extended by Doral Soccer Club Inc. (DSC) and requires prompt payment. A fee of \$35.00 will be charged for any returned checks.

The full season registration fee is due by November 1st, 2024.

All payments are final and non-refundable.

As the parent/guardian of the registrant, I hereby acknowledge that failure to meet my financial commitments may lead to the registrant being classified as "Not in Good Standing" with the club and its affiliated state organizations. Consequently, the registrant's participation privileges will be suspended until the obligations are met by the due date of November 22, 2024. Furthermore, this status will affect the registrant's eligibility to register with any other state affiliated organizations.

As the parent/guardian of the registrant, a member of a competitive team affiliated with Doral Soccer Club, I acknowledge my responsibility to contribute to all coaching fees, referee fees, travel expenses, and/or tournament fees for the season. These fees, as determined by the team, will be evenly divided among all team members, and must be paid by the specified deadline. Failure to fulfill these obligations may jeopardize both the team's and the players' participation in the respective event, with the exception of major injuries which will be exempted.

As the parent/guardian of the registrant, I acknowledge that certain tournaments throughout the season require mandatory attendance. Any player who fails to attend such tournaments may be subject to penalties determined by the coach, at their discretion. However, players with major injuries will be exempt from this requirement.

Doral Soccer Club does not offer transportation services for practices or games. Parents assume full responsibility for arranging any carpool arrangements with other team members. Doral Soccer Club bears no responsibility for any accidents that may occur while your child is being transported to a team event in a personal vehicle or hired transportation.

- Players will refrain from using any abusive, insulting language, taunting, or any other unsportsmanlike conduct treating everyone with dignity and respect.
- Players will honor the commitment to the club.
- Players will take full responsibility of their actions and conduct in a manner that upholds the reputation of the sport and the club which reflects positively on themselves, my team, and the community.
- Players will maintain a good physical condition which includes healthy eating habits, proper sleep, and exercise for ideal optimal performances.
- Players will prioritize the success of the team over individual achievement, working together with teammates to achieve common goals.
- Players will prioritize the safety and well-being of myself and others, following safety guidelines and taking precautions to prevent injuries.
- Players will recognize that training sessions are as important as official games.
- Players will take full responsibility for attending all team events and training sessions.
- Players will respect the head coach's role and decisions along with club player development methods.
- Players will respect facility rules, help maintain soccer fields clean and report any damages to facilities.

- Parents will always show good sportsmanship, emphasizing effort, and enjoyment of the game over winning at all costs.
- Parents will support, encourage, and respect all players, coaches, opponents, spectators, and game officials.
- Parents will demonstrate a positive attitude, with or about, their child's teammates, team, club, and coaching staff.
- Parents will help promote healthy competition, refrain from any abusive or insulting language and discourage over aggressive or unsportsmanlike behavior.
- Parents will honor the commitment to the club.
- Parents will take responsibility to make sure player arrives on time prior to training sessions and official games throughout the entire season.
- Parents will respect the coach's role and decisions.
- The 24-hour rule: waiting a full day after a game or training sessions to respectfully communicate with head coach or club directors seeking clarification on expectations, concerns, and feedback in a constructive manner.
